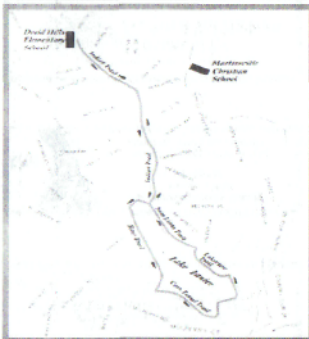


COURSE MAP



DIRECTIONS TO MARTINSVILLE PARKS & RECREATION (OLD DRUID HILLS SCHOOL)

Danville: Rt. 58 into Martinsville. Turn left at light, just past Hooker Furniture, onto Brookdale Rd.; Just past Shiloh Way of the Cross Church turn right onto Parkview. Go to stoplight, turn left onto Spruce. Take 1st street to the right which is Indian Trail and school is 3/10 of mile on right.

Greensboro: Rt. 220 to Martinsville. Right on Rives Rd. at light (2 miles past M'ville Speedway). Go 2 1/4 miles, turn right on Spruce St. Turn right onto Indian Trail, School is 3/10 mile on the right.

Roanoke: Rt. 220 to Business 220 and through Collinsville. Turn left on Commonwealth Blvd. at light (near Wal-Mart). Go 1 mile, turn right on Market St. at light (near Liberty Fair Mall). Go 1 mile, cross Starling Ave. onto Mulberry Rd. Go 1/2 mile, turn left on Spruce St. Go through 1st stoplight and take 1st road to right which is Indian Trail, school is 5/10 mile on right.

Lynchburg: Rt. 29 S to Chatham; Rt. 57 W to intersection with Rt. 58. Right on Rt. 58 and follow directions for Danville(above).

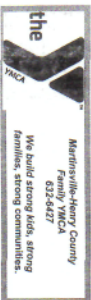
